#### **ORDINANCE NO. 548**

AN ORDINANCE OF THE CITY OF BLUE MOUND, TEXAS AMENDING THE TEXT OF THE COMPREHENSIVE ZONING ORDINANCE, EXHIBIT A TO CHAPTER 14, "ZONING" OF THE BLUE MOUND CODE OF ORDINANCES; BY AMENDING SECTION 10, "E" COMMERCIAL DISTRICT, TO ALLOW AUTOMOBILE, MOTORCYCLE AND TRAILER SALES, OR SALES OR RENTAL AREAS AS A PERMITTED USE AND REQUIRE THAT LOT AREAS FOR AUTOMOBILE SALES OR RENTALS ARE AT LEAST 33,000 SQUARE FEET; BY AMENDING SECTION 12, "F" COMMERCIAL DISTRICT, TO REQUIRE A MINIMUM SIZE OF 33,000 SQUARE FEET FOR AUTOMOBILE SALE OR RENTAL AREAS; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A PENALTY FOR VIOLATION; PROVIDING FOR PUBLICATION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Blue Mound, Texas is a Type A general-law municipality located in Tarrant County, created in accordance with the provisions of Chapter 6 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the City Council of the City of Blue Mound has previously adopted regulations governing land uses and lot areas that are contained in the Comprehensive Zoning Ordinance; and

WHEREAS, notice has been published at least fifteen (15) days prior to the time and place of a public hearing held before the City Council concerning the provisions contained herein, which public hearing has been duly held; and

WHEREAS, the City Council has determined that the amendments to the Comprehensive Zoning Ordinance herein made are in the best interest of the health, safety and general welfare of the citizens of the City of Blue Mound.

### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLUE MOUND, TEXAS THAT:

#### **SECTION 1.**

That the Blue Mound Comprehensive Zoning Ordinance is hereby amended by amending Appendix A to Chapter 14, "Zoning," in the Blue Mound Code of Ordinances by amending Section 10(B)(a) to add automobile, motorcycle and trailer sales, or sales or rental areas as a permitted use and to require that automobile sales or rental areas must be at least 33,000 square feet to read as follows:

#### **"SECTION 10 "E" COMMERCIAL DISTRICT**

#### \*\*\*

B. <u>USE REGULATIONS</u> In the "E" Commercial District, no residential buildings will be erected; however, residential uses existing at the time of the passage of this ordinance will remain as legal nonconforming uses under the provision of Section 22. In the "E" Commercial District, no buildings or land use shall be used and no buildings shall be hereafter erected, reconstructed,

altered or enlarged, unless otherwise provided in this ordinance, except for one or more of the following uses:

#### a. <u>PERMITTED USES</u>

- 1. Antique shops.
- 2. Auditorium, theaters, cinemas.
- 3. Auto parking areas.

4. Automobile, motorcycle and trailer sales, or sales or rental areas provided that the lot area for automobile sales or rentals shall be at least thirty-three thousand square feet (33,000 sq. ft.).

5. Bakeries, providing that the floor areas do not exceed three thousand square feet (3,000 sq. ft.).

#### **SECTION 2.**

That the Blue Mound Comprehensive Zoning Ordinance is hereby amended by amending Appendix A to Chapter 14, "Zoning," in the Blue Mound Code of Ordinances by amending Section 12(B)(a)(2) to require that automobile sales or rental areas must be at least 33,000 square feet to read as follows:

#### **"SECTION 12 "F" COMMERCIAL DISTRICT**

\*\*\*

B. <u>USE REGULATIONS</u> In the "F" Commercial District, no buildings or land shall be used and no buildings shall be hereafter erected, reconstructed, altered or enlarged, unless otherwise provided in this ordinance, except for one or more of the following uses:

- a. <u>PERMITTED USES</u>
  - 1. Any use permitted in the "E" Commercial District.

2. Automobile, motorcycle and trailer sales, or sales or rental areas provided that the lot area for automobile sales or rentals shall be at least thirty-three thousand square feet (33,000 sq. ft.).

#### SECTION 3. CUMULATIVE

This Ordinance shall be cumulative of all provisions of ordinances of the City of Blue Mound, Texas, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

### SECTION 4. SEVERABILITY

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause, sentence paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

#### SECTION 5. PENALTY

Any person, firm or corporation who violates, disobeys, omits, neglects or refuses to comply with or who resists the enforcement of any of the provisions of this Ordinance shall be guilty of a misdemeanor and upon conviction shall be punished by a fine in accordance with Section 1.01.009 of the Code of Ordinances, City of Blue Mound, Texas.

### SECTION 6. SAVINGS

All rights and remedies of the City of Blue Mound are expressly saved as to any and all violations of the provisions of the Code of Ordinance of the City of Blue Mound, as amended, or any other ordinances affecting zoning which have accrued at the time of the effective date of this Ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances, same shall not be affected by this Ordinance but may be prosecuted until final disposition by the courts.

#### SECTION 7. PUBLICATION

The City Secretary is authorized and directed to cause publication of the descriptive caption and penalty clauses of this ordinance as provided by law.

### SECTION 8. EFFECTIVE DATE

This Ordinance shall be in full force and effect after its passage and publication, and it is so ordained.

### FIFTH AMENDED DECLARATION OF LOCAL DISASTER AND PUBLIC HEALTH EMERGENCY CITY OF BLUE MOUND, TEXAS

WHEREAS, in December 2019 a novel coronavirus, now designated COVID-19, was detected in Wuhan City, Hubei Province, China, with symptoms of COVID-19 including fever, cough, and shortness of breath and with outcomes ranging from mild to severe illness and in some cases death;

WHEREAS, on January 30, 2020, the World Health Organization Director General declared the outbreak of COVID-19 as a Public Health Emergency of International Concern (PHEIC), advising countries to prepare for the containment, detection, isolation and case management, contact tracing and prevention of onward spread of the disease;

WHEREAS, on March 5, 2020, the World Health Organization Director General urged aggressive preparedness and activation of emergency plans to aggressively change the trajectory of this epidemic;

WHEREAS, on March 11, 2020 the World Health Organization (WHO) declared COVID-19 a worldwide pandemic;

WHEREAS, the Centers for Disease Control and Prevention is closely monitoring the growing number of cases that have spread into the United States and the identification of "community spread" cases of COVID-19 in the United States signals that transmission of the virus is occurring;

WHEREAS, COVID-19 spreads between people who are in close contact with one another through respiratory droplets produced when an infected person coughs or sneezes;

WHEREAS, the continued worldwide spread of COVID-19 presents an imminent threat of widespread illness, which requires emergency action for the protection of the people of the City of Blue Mound;

WHEREAS, Tarrant County Judge Glen Whitley issued a Declaration of Disaster Due to Public Health Emergency for Tarrant County for COVID-19 on March 13, 2020, and a First Amended Declaration of Local Disaster Due to Public Health Emergency on March 18, 2020, and a Second Amended Declaration of Local Disaster Due to Public Health Emergency on March 21, 2020, and an Executive Order relating to COVID-19 on March 27, 2010 and on April 3, 2020;

WHEREAS, Governor Greg Abbott issued a State of Disaster for all Texas counties for COVID-19 on March 13, 2020, and numerous Executive Orders relating to COVID-19 preparedness and mitigation on March 19, 2020, on March 22, 2020, on March 24, 2020, on March 26, 2020, on March 29, 2020, on March 30, 2020 and on March 31, 2020;

WHEREAS, President Donald Trump declared a State of National Emergency for the United States of America on March 13, 2020;

WHEREAS, pursuant to the Texas Disaster Act of 1975, the Mayor is designated as the emergency management director of the City of Blue Mound, and may exercise the powers granted to the governor on an appropriate local scale;

WHEREAS, a declaration of local disaster and public health emergency includes the ability to reduce the possibility of exposure to disease, control the risk, promote health, compel persons to undergo additional health measures that prevent or control the spread of disease including isolation surveillance, quarantine, or placement of persons under public health observation, including the provision of temporary housing or emergency shelters for persons misplaces or evacuated;

WHEREAS, a declaration of local disaster is necessary to authorize the furnishing of aid and assistance to the City of Blue Mound from the governor for state and federal resources allocated toward this disaster;

WHEREAS, by this FIFTH Amended Declaration of Local Disaster and Public Health Emergency, I declare all rules and regulations that may inhibit or prevent prompt response to this threat suspended for the duration of the incident;

WHEREAS, pursuant to the authority granted to the Mayor under the Texas Disaster Act of 1975, I authorize the use of all available resources of state government and political subdivisions to assist in the City's response to this situation;

WHEREAS, I, Alan Hooks, the Mayor of the City of Blue Mound have determined that extraordinary and immediate measures must be taken to respond quickly, prevent and alleviate the suffering of people exposed to and those infected with the virus, as well as those that could potentially be infected or impacted by COVID-19; and,

WHEREAS, I, Alan Hooks, the Mayor of the City of Blue Mound issued the Mayor's Proclamation Declaring a Local State of Disaster on March, 17, 2020, issued the First Amended Declaration of Disaster and Public Health Emergency on March 24, 2020, issued the Second Amended Declaration of Disaster and Public Health Emergency on March 24, 2020, issued the Third Amended Declaration of Disaster and Public Health Emergency on March 31, 2020, and hereby issue this FIFTH Amended Declaration of Disaster and Public Health Emergency on March 31, 2020, and hereby issue this FIFTH Amended Declaration of Disaster and Public Health Emergency of March 31, 2020, and hereby issue this FIFTH Amended Declaration of Disaster and Public Health Emergency to implement additional measures to ensure the protections of the residents of the City of Blue Mound.

### NOW THEREFORE, BE IT PROCLAIMED BY THE MAYOR OF THE CITY OF BLUE MOUND, TEXAS:

- 1. That a state of disaster and public health emergency is hereby declared for the City of Blue Mound, pursuant to §418.108(a) of the Texas Government Code.
- 2. That the state of disaster and public health emergency shall continue for a period of not more than seven days of the date hereof, unless the state of disaster and public

health emergency is continued by the City Council of the City of Blue Mound, Texas, pursuant to §418.108(b) of the Texas Government Code, at which time the City Council of the City of Blue Mound, Texas will specify the period of extension.

- 3. That this declaration of a local state of disaster and public health emergency shall be given prompt and general publicity and shall be filed promptly with the City Secretary, pursuant to §418.108(c) of the Texas Government Code.
- 4. That Tarrant County's and City of Blue Mound's interjurisdictional Emergency Management Plan is activated and implemented, pursuant to §418.108(d) of the Texas Government Code.
- 5. That this declaration authorizes the City to take any actions necessary to promote health and suppress disease, including quarantine, examining and regulating hospitals, regulating ingress and egress from the City, and fining those who do not comply with the City's rules, pursuant to §122.005 of the Health and Safety Code, including but not limited to:
  - a. Prohibit restaurant dine-in service and self-serve food service
  - b. Restrict gathering places to no more than 10 persons
  - c. Close public and neighborhood playgrounds
  - d. Encourage social distancing of at least six feet
  - e. Postpone use of City facilities for public and court activities
  - f. Waive fees associated with on-line transactions to encourage use
  - g. Suspend water shut offs and waive late fees related to city water accounts
  - -h. Suspend bulk trash pickup fees
  - i. Provide flexible work locations and additional paid leave for City employees
  - j. Require citizens to wear a mask in public to prevent spread of the disease
- 6. That this declaration shall adopt for the City of Blue Mound all rules, regulations and limitations issued by Tarrant County and the State of Texas contained in executive orders or disaster declarations issued by those entities for the Coronavirus Disease 2019 public health emergency as applicable to the City of Blue Mound. In the event of a conflict between the rules, regulations and limitations issued by Tarrant County, and the State of Texas, the more restrictive of the rules, regulations and limitations shall be adopted.
- 7. That this declaration hereby authorizes the use of all lawfully available enforcement tools.
- 8. That this declaration shall take effect at 5:00pm, April 16.

### **ORDINANCE NO. 549**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BLUE MOUND, TEXAS, APPROVING THE EXTENSION OF THE MAYOR'S FIFTH AMENDED DECLARATION OF PUBLIC HEALTH EMERGENCY UNTIL\_\_\_\_\_\_; ALLOWING FOR THE AUTOMATIC ADOPTION OF ALL RULES, REGULATIONS AND LIMITATIONS ISSUED BY TARRANT COUNTY AND THE STATE OF TEXAS CONTAINED IN EXECUTIVE ORDERS OR DISASTER DECLARATIONS ISSUED BY THOSE ENTITIES FOR THE CORONAVIRUS 2019 PUBLIC HEALTH EMERGENCY AS APPLICABLE TO THE CITY OF BLUE MOUND; AND PROVIDING FOR A PENALTY FOR VIOLATIONS AS ALLOWED UNDER STATE LAW.

**WHEREAS**, the City of Blue Mound, Texas is a Type A general-law municipality located in Tarrant County, created in accordance with the provisions of Chapter 6 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

**WHEREAS,** on April 21, 2020, the Mayor issued a Fifth Amended Declaration of Local Disaster and Public Health Emergency for the City of Blue Mound, Texas resulting from a determination that extraordinary and immediate measures must be taken to quickly respond, prevent, and alleviate the suffering of people exposed to and those infected with the COVID-19 virus, as well as those that could potentially be infected or impacted by COVID-19; and

WHEREAS, the conditions necessitating a declaration of a state of disaster continue to exist; and

**WHEREAS**, §418.108(b) of the Texas Government Code provides that a local state of disaster may not be continued for a period in excess of seven days without the consent of the governing body of the political subdivision; and

WHEREAS, the City of Blue Mound, Texas, and Tarrant County, Texas have in place an interjurisdictional Emergency Management Plan (the Plan) adopted under Chapter 6 of the Code of Ordinances and Chapter 418 of the Texas Government Code (the Texas Disaster Act); and

**WHEREAS**, the City Council desires to extend the declaration of local disaster and expressly provide for penalties of violations of the plan and rules, regulations or directives adopted under the Plan and state of local disaster declarations;

**WHEREAS**, the City Council finds that this ordinance is in the best interest of the City and furthers the public health and welfare of the City.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLUE MOUND, TEXAS, THAT:

### **SECTION 1**

The Fifth Amended Declaration of Local Disaster and Public Health Emergency issued for the City of Blue Mound by the Mayor on March 22, 2020, shall continue until 11:59 pm, May 19, 2020 and specifically adopts the rules and regulations contained therein pursuant to \$122.005 of the Health and Safety Code.

### **SECTION 2**

This ordinance shall further adopt for the City of Blue Mound, Texas all rules, regulations and limitations issued by Tarrant County and the State of Texas contained in executive orders or disaster declarations issued by those entities for the Coronavirus 2019 public health emergency as applicable to the City of Blue Mound. In the event of a conflict between the rules, regulations and limitations issued by Tarrant County and the State of Texas, the more restrictive of the rules, regulations and limitations and limitations shall be adopted.

#### **SECTION 3**

The Tarrant County and City of Blue Mound interjurisdictional Emergency Management Plan shall continue to be implemented. Any violation of rules, regulations, or directives adopted pursuant to the Emergency Management Plan or a Declaration of Local Disaster is an offense. Any person, firm, or corporation who violates, disobeys, omits, neglects, or refuses to comply with or who resists the enforcement of any of the provisions of the Emergency Management Plan or a Declaration of Disaster shall be fined in accordance with §418.173 of the Texas Government Code or §122.005 of the Health and Safety Code, as applicable.

#### **SECTION 4**

That the City Secretary of the City of Blue Mound is hereby directed to publish this ordinance as required by law.

#### **SECTION 5**

This ordinance shall be in full force and effect from and after the date of its passage and publication as required by law, and is so ordained.
